Dear fellow regional Australians,

Not long ago, regional Australia was reeling from the devastation of widespread bushfires.

It was the most shocking season in memory. It came fast and heavy on top of the worst impacts of a prolonged drought followed by flooding in some areas.

Now we find ourselves in the fight of our lives – confronting the very real threat of coronavirus (COVID-19).

We are no stranger to challenges. We have faced them head-on. Repeatedly.

But this is a fight like no other

Coronavirus knows no bounds. It does not discriminate. It can affect any age, but our elderly are more at risk of the devastatingly genuine potential of death.

In order to mitigate the risk to ourselves and each other, strict but necessary measures have been enforced.

But it is a small price to pay to save members of our community and minimise impacts on our economy.

Roll-out of General Practitioner-led COVID 19 respiratory clinics

The first rural General Practitioner-led COVID-19 respiratory clinic in New South Wales has officially opened at Wagga Wagga's Glenrock Country Practice.

Other GP-led respiratory clinics have since opened in Cowra, Gundagai and Young and are part of the Australian Government's \$2.4 billion health package to combat COVID-19.

Wagga Wagga is a health hub for the Riverina and the Murrumbidgee region with more than 250,000 people relying on the regional city's health services and medical professionals.

These local clinics will help to reduce future pressure on hospital emergency departments and other general practices as we ease restrictions and brace for any potential outbreaks.

Rural and regional residents deserve health care services which are just as good as those provided in our major cities and the national roll-out of these new clinics goes to addressing that.

The Government is investing \$206.7 million to establish more than 100 respiratory clinics across Australia, including in rural and regional areas. Additionally, more than 160 fever clinics, jointly funded by the Commonwealth and State and Territory Governments, are also in operation across Australia.

Help to continue stopping the spread

Even though we are suppressing the spread of the virus, it remains vitally important that we continue to adhere to the restrictions as recommended by the Chief Medical Officer Professor Brendan Murphy.

The New South Wales Government has expanded the criteria for testing to include anyone who

displays cold or flu-like symptoms. Please do not take the risk of potentially spreading this deadly virus to those around you who are more vulnerable – take the time to get tested and be sure to do your bit to save lives and protect livelihoods.



Regional air services vital to local communities

Regional Australians are relying on air services now more than ever, with communities needing access to medicines, medical equipment, critical supplies and essential personnel.

That's why I was determined to fund the \$198 million Regional Air Network Assistance Package, to secure a regional aviation network for locals and others in regional areas during this pandemic.

I have worked tirelessly as the Member for Riverina and Minister responsible for aviation to ensure our community and those across regional Australia get the services they need.

Thanks to our funding, REX will continue twice-weekly return flights from Sydney to Wagga and thrice-weekly return flights from Wagga to Melbourne via Albury. Parkes will be serviced by three weekly return flights to Sydney, via Bathurst.

QantasLink will be flying return from Wagga to Sydney twice a week.

We've committed more than \$1.2 billion of support to our aviation industry because we want the sector to get to the other side of this pandemic in the best position possible.

This includes:

- \$715 million package waiving fuel excise and Government changes backdated to 1 February 2020;
- \$100 million to provide direct financial support to smaller regional airlines;
- An initial \$165 million to maintain key routes for eight weeks.

We are ensuring secure and affordable access for passengers who need to travel, including our essential workers such as frontline medical personnel and defence personnel, as well as supporting the movement of essential freight such as critical medicine and personal protective equipment.

JobKeeper Payment to help workers

The \$70 billion JobKeeper Payment, one of the most important pieces of legislation in our nation's history, is keeping thousands of regional Australians in jobs through the pandemic.

The fortnightly \$1,500 payment will be paid to employers for each eligible employee who was on their books on 1 March 2020 and is retained or continues to be engaged by that employer.

Eligible employers include businesses structured through companies, partnerships, trusts and sole traders. Not-for-profit entities, including charities, will also be eligible.

Self-employed individuals are also eligible to receive the JobKeeper Payment.

Helping local communities rebuild after devastating bushfires

While the bushfires have been put out, the devastation remains in those local communities hit by one of the worst fire seasons in living memory.

Thanks to all the courageous efforts of every person who assisted in some way during the crisis – from the brave firefighters to the volunteers who carted water from town to town – you all did Australia proud in your efforts to save lives and homes.

A new \$650 million package of support from the Federal Government is helping towns and regions get back on their feet.

The Regional Bushfire Recovery and Development Program will help bushfire-affected communities share in \$448.5 million to support the delivery of local recovery plans with priority given to the most severely affected regions, drawing on local voices and local governments in close partnership and as part of cost-sharing arrangements with the New South Wales Government.

I urge local communities to work with the State Government to provide the National Bushfire Recovery Agency with their priority projects as soon as possible. Sadly, 33 people have lost their lives, including six brave firefighters; 2900 homes have been confirmed lost; and more than 10.4 million hectares were burnt out.

We have been focused on the immediate relief we need to get to people on the ground while also planning for the ongoing recovery effort.

Recovery effort and our \$2 billion National Bushfire Recovery Fund

- Forestry Transport Assistance (\$15 million): to assist the forestry industry with the increased costs of transporting burned salvaged logs over longer distances to surviving timber mills or storage sites in bushfire-affected areas
- Community Wellbeing and Participation (\$13.5 million): backing Primary Health Networks with additional funding to provide critical, localised emotional and mental health support for bushfire-affected individuals
- Bushfire Recovery for Species and Landscapes (\$149.7 million): supporting efforts that go beyond the immediate devastation on species and natural assets through habitat regeneration, waterway and catchment restoration including erosion control, weed and pest management
- Telecommunications Emergency Resilience (\$27.1 million as well as \$10 million from the Mobile Blackspot Program): strengthening telecommunications capabilities prior to future natural disasters
- \$60 million to support severely impacted local councils
- \$76 million for mental health support through counselling and Medicare
- \$40 million paid to charities – including The Salvation Army and St Vincent de Paul – to enable them to provide direct assistance on the ground by way of food, fuel and cash

Fast Facts: National Bushfire Recovery Agency

Immediate assistance

- Australian Government Disaster Recovery Payment (AGDRP) – \$1000 per eligible adult and \$400 per eligible child. The Australian Government has announced the child payment will double to \$800
- More than \$105 million paid through AGDRP and another \$15 million in children's payments so far
- Australian Government Disaster Recovery Allowance – up to 13 weeks of income support. We're also simplifying the application process
- Payments to Volunteer Firefighters – up to \$300 per day for lost income (up to \$6,000)
- Up to \$75,000 recovery grants to primary producers and farmers (initial estimate \$100 million)
- \$50,000 grants to affected businesses
- Loans of up to \$500,000 with deferred repayments and concessional rates
- Single point of contact – a new hotline and 10 new financial counsellors: **180 22 66**
- Delay tax filing requirements
- Job seekers are able to undertake voluntary work activities to contribute towards their Mutual Obligation requirements, in eligible not-for-profit organisations, which can include rural, country and emergency fire services

Repackaging small business assistance

- A new \$10,000 grant for businesses which have experienced a 40 per cent drop in revenue over a three-month period, compared to the previous year, as a result of the bushfires
- Quicker access to existing loans by cutting red tape with fewer documents and security requirements
- More boots on the ground to help small businesses access appropriate help

A Royal Commission will focus on:

- improving natural disaster management co-ordination across all levels of government;
- improving Australia's preparedness, resilience, and response to natural disasters, across all levels of government;
- the legal framework for the Commonwealth's involvement in responding to national emergencies and how that works with State and Territory legal frameworks.

Australian Defence Force

- Assisted efforts since the start of the season in September
- First ever compulsory call-out of reservists
- More than 6,500 personnel on the ground as well as deployed the HMAS *Choules*, *Sycamore* and *Adelaide*



Drought support there for those who need it

Even though we have seen some welcome rain in our region, the Federal Government knows our local communities are still suffering from the effects of the drought.

We are all hopeful the worst of the drought has passed, but we know the recovery will take many years.

The Australian Government has a three-part plan to tackle the most pressing issues for people affected by drought, including more than \$8 billion in assistance and concessional loans:

1. Helping those affected right now

This includes the Farm Household Allowance, Rural Financial Counselling Service and \$65.4 million for the Drought Community Support Initiative, which provides \$3,000 to farmers, farm workers and suppliers/contractors who are facing hardship due to drought. There is also \$29.9 million for mental health and wellbeing support, two-year interest free Drought Loans for farmers and tax relief, over two rounds.

2. Supporting wider communities

This includes \$300 million for the Drought Communities Programme Extension, redirecting the \$200 million Round Four of the Building Better Regions Fund to drought-affected communities and an additional \$138.9 million for Roads to Recovery for drought-affected communities. In addition, we are also piloting a \$7 million small business support program, providing two-year interest free loans for agriculture-dependent small businesses, providing \$15 million support for schools and early child care centres and funding \$15 million in Tackling Times Together grants.

3. Building a more drought resilient Australia

The Government is enhancing long-term resilience and preparedness to withstand drought periods in the years ahead. This includes the \$5 billion Future Drought Fund and water infrastructure investment programs.

It's time to build more dams

I established the National Water Grid to ensure our regions are best placed to grow and thrive in the coming decades.

Water is the lifeblood of our nation and we owe it to our regional producers and communities to deliver long-term, sustainable water infrastructure to help farmers recover and build resilience from drought.

The National Water Grid will deliver strategic planning and project management for water infrastructure across the nation.

It will bring together the world's best scientists, water experts and local stakeholder engagement to harvest and harness our most critical asset for future generations — ensuring science, not politics — drives future decision making on water policy and infrastructure.

Supporting small business

The Government is supporting small businesses in drought areas through part two of its drought plan. The \$300 million Drought Communities Programme Extension, \$200 million round of the Building Better Regions Fund and additional \$138.9 million for Roads to Recovery in drought-affected communities are all designed to do one thing – give a boost to businesses in rural and regional towns. This happens when new projects are being built, people have money in their back pocket and can spend that money in the local café, the IGA, the gift shop or the pub up the road.

In addition, the Government is providing new Small Business Drought Loans for small businesses dependent on agriculture. This will let these small businesses borrow, interest free for two years and up to \$500,000, to pay for business expenses or refinance. This could potentially save businesses up to \$30,000 a year compared to a commercial small business loan.

Key Government initiatives

- \$47 million extend the Drought Communities Programme to more councils, including 11 in the Riverina and Central West
- \$20 million to keep kids in school and \$5 million for childcare
- \$1 billion worth of drought loans up to \$2 million with no repayments or interest for the first two years to make it cheaper for farmers to buy fodder, transport stock, build water infrastructure, agist cattle, mend fences or refinance existing debt
- A new Small Business Drought Loan up to \$500,000 with the same conditions
- \$200 million extra for the Building Better Regions Fund
- \$138.9 million extra for Roads to Recovery
- Improved Farm Household Allowance and to make it available to more farmers more often

COVIDSafe app to help slow spread

The voluntary coronavirus app, COVIDSafe, is an important tool to help keep you and your family safe from further spread of virus.

By installing this app, you will save lives and you will protect livelihoods.

I thank the more than 5.5 million people who have downloaded the app at the time of publication.

The app uses Bluetooth technology in your phone to speed up the contact tracing process essential to stamping out any COVID-19 outbreaks in our region. COVIDSafe works by quickly identifying people who have been in close contact with someone diagnosed with coronavirus.

Unless and until a person is diagnosed with COVID-19, no contact information collected in the app can be accessed. Once a person agrees and uploads the data, only the relevant state or territory public health officials will have access to information. The only information they can access is that of close contacts.

Once the pandemic is over the app and the information on it will be deleted permanently.
